EXECUTIVE SUMMARY OF ITEM BACKGROUND:

On November 13, 1998, Congress enacted a law (Section 409 of P.L. 105-383) that provides for cities, counties and municipalities to be similarly designated as a "Coast Guard City" or "A Coast Guard Community". A "Coast Guard City" program recognizes the communities that support Team Coast Guard across the nation. A city, county, or municipality earns the distinction of being named a Coast Guard City by making special efforts to acknowledge the professional work to the men and women assigned to its area. The city's efforts illustrate a longstanding and enduring relationship the community has made for the members of the Coast Guard Community.

Captain John Spaner, Sector Commander of the United States Coast Guard, San Diego, now seeks to designate the City of San Diego to be a Coast Guard City.

The San Diego community and the Coast Guard have developed strong relationships that ensure service members and their families feel comfortable in their home away from home while contributing to morale and service excellence.
